MINUTES OF THE ORDINARY PARISH COUNCIL MEETING HELD ON MONDAY 23 FEBRUARY 2015 AT CLAYTON GREEN LIBRARY AT 7.30 PM

POLICE LIAISON: The Councillors were provided with a report on the January 2015 crime statistics which were 11 for Clayton-le-Woods and 30 for Clayton Brook.

7379: MINUTES: It was **RESOLVED** to approve and sign the minutes of the meeting held on 19th January 2015 subject to the following amendments: Apology received from A Cross; PCSO Paul Harrison in attendance instead of PC Jim Colclough.

7380: OPEN SPACES MAINTENANCE CONTRACTS: The Clerk informed the Council that grass cutting, spring bulbs and path maintenance quotations had been received from DWG NW Limited and Bedrock Landscapes. It was **RESOLVED** that the maintenance contracts be approved for Year 2015/16.

7381: DONATION OF INDIGENOUS TREES/SHRUBS: The Chairman explained to the Council that as part of the Planning conditions for the felling of trees in Back Lane Woods the same number of trees as was being removed had to be planted. It was noted that those trees could be planted on the Carr Brook trim trail as it was advised not to plant the trees in Back Lane woods due to density issues.

It was **RESOLVED** to donate up to 50 (fifty) indigenous trees/shrubs to Chorley Council to enhance the local environment. The six trees required under the Tree Preservation Order would have to be identified and logged with the Planning Department at Chorley Council. It was requested that the Clerk confirm the details to Chorley Council and report back in due course.

7382: NORTH WEST IN BLOOM FLOWERBED/ENTRY 2015: It was noted that Chorley Council had offered to move the flowerbed to an alternative site. It was **RESOLVED** that the flowerbed would be moved by Chorley Council at a cost of around £500 and the Parish Council would be invoiced in due course.

It was **RESOLVED** that the Council would enter the North West in Bloom Competition 2015 with the entry fee being £130.00 (Large Town Status)

7383: WILDERSWOOD POND: It was **RESOLVED** not to undertake a pond project at the present time. The Parish Council would liaise with Chorley Council to plan any future work.

7384: APPOINTMENT OF INTERNAL AUDITOR: It was **RESOLVED** that Mr Alan Platt would be approached to undertake the role of Internal Auditor once the Terms of Reference and fee had been finalised.

7385: REVIEW OF INTERNAL FINANCIAL REGULATIONS/DELEGATION: It was **RESOLVED to** appoint a Finance Working Group to meet to scrutinise the Internal Financial Regulations and table recommendations at the next Parish Council Meeting.

7386: REVIEW OF CLAYTON GREEN SKATE PARK ESTIMATES: The Clerk reported that 3 quotations had been received.

It was **RESOLVED** that Bedrock Landscapes Ltd. be appointed to undertake the replacement of the fencing at the Skate Park at Clayton Green at a cost of £2,262 + VAT however the confirmation letter would indicate that the company should be fully aware of the required RoSPA recommendations British Standards as regards skate parks and insurance requirements.
