7356: ASDA TROLLEYS AND ROUNDABOUT PLANTER: The Clerk confirmed that Asda would be planting up the planter at the Clayton Green roundabout shortly. It was **RESOLVED** that the issue with the Asda trolleys being left around the parish would be held in abeyance whilst the Manager works on trying to rectify the situation.
