the War Memorial Committee look into alternate streams of income to undertake necessary work on the grounds.

2. Reduce Bowling Green Maintenance by £1,000 to £2,500. Agreed
3. Increase Summer Fair Budget by £1,500 to £11,500. Agreed
4. Increase Christmas Tree Budget by £500 to £7,500. Agreed

This would adjust the overall budget by some £1,750.

From the changes it was noted that the Precept would be set at £30.00 on a Band D Property. Which was no increase from 2023/24 level.

It was proposed that the revised budget be forwarded to the FPC meeting for approval on 15th January 2024. This was agreed on unanimously.
